With projects in more than 30 Aboriginal communities, Kaunitz Yeung have had a long association with leading community development projects, and their work has been awarded internationally as well as locally, including three awards for the Biripi Aboriginal Health Clinic at the recent 2018 NSW Architecture Awards. The firm's cofounder and Director, David Kaunitz, also authored the 2017 update to the 'Australian Government, Department of Health, Aboriginal and Torres Strait Islander Funded Capital Works Projects – Facility Design Guidelines'.

Most recently the firm has completed two Aboriginal healthcare clinics for the Puntukurnu Aboriginal Medical Service (PAMS) in the East Pilbara, Western Australia (WA), and this month were awarded the architectural and project management contract for the PAMS healthcare hub in Newman, WA.
